The initial Portland Clean Cities Coalition was among the first established back in November 1993. Partners at that time included: City of Portland, Multnomah County, State of Oregon, US General Service Administration, Northwest Natural Gas, Portland General Electric, Pacific Power, Franz Bakery, and more. Now, more than 65 communities have created similar partnerships and are working together.
